Targeted technology upgrade on Mondi Świecie's PM 5 boosts efficiency

ŚWIECIE, **POLAND / HEIDENHEIM**. As previously announced, Mondi has successfully completed a comprehensive modernization of the PM 5 paper machine at its containerboard mill in Świecie, Poland. The project, which included a variety of technological upgrades, was completed on schedule and the improvements in product quality and productivity strengthen the mill's profile. The machine produces the two containerboard grades ProVantage Kraftliner and ProVantage SmartKraft Brown and its modernization enables Mondi to better meet the growing customer demand for heavy-duty packaging.

"The completion of this project marks a milestone for Mondi Świecie, enabling us to advance our operations and deliver even higher-quality paper to our customers. I am proud of the team's exceptional skills and commitment, which were crucial in achieving these goals, and we valued the strong partnership with Voith on this important project" said Tomasz Katewicz, Managing Director of Mondi Świecie.

The upgrade included the modification of both headboxes, the installation of a new DuoShake DG800 system and a Tandem NipcoFlex press including a ModuleSteam steam blow box. In addition, a new PrevoCut water jet tail cutter and a TrimSquirt edge trimming system from the Prevo family were installed, along with a customized tail threading system. Modifications were made to the dryer section to reduce vibration and maximize drying capacity. Voith also supplied a complete package of paper machine clothing, including forming fabrics, press felts and press sleeves for the start-up and optimization phase of PM 5.

The scope of supply for the approach flow system included a new IntegraGuard screen for thick stock and the overhaul of the existing screen for the dilution water line in the back ply, as well as a new C-Bar screen basket. In addition, a new HiClean HCL5 cleaner system with EcoMizer technology was installed for the back ply.

"This project and the results achieved underline our quality as a reliable partner and leading rebuild specialist in the paper industry," says Philip Schnellinger, Process Technology Manager at Voith Paper. "The efficient completion of the project in just nine months shows that our passion and expertise pay off for the customer."
