- **Format:** Only PDF-attachments can be sent.
- **File name:** The file must be named with one of the following words: Anhang, Anlage, appendix, attachment, adjunto, annex oder liit.
- **Submission:** A separate e-mail must be sent for each invoice with attachment.
- **Combination:** The invoice and attachment can be combined in a single PDF document.
